The Government has also prescribed the books to be introduced for Classes I and VI, which have to be followed for the Compulsory Teaching & Learning of the Telugu language as per Act 10 of 2018 & the connected Rules, and also follow the guidelines issued in G.O.Ms No.36, School Education (General) Department, Dt. 16.12.2017 for the safety and security of the children in the schools.
- The School Management should submit/comply with CBSE affiliation norms and all the records accordingly.
